Meeting Commenced at 15:30

MT thanked everyone for attending and started the meeting with the Standing down of him as chairman, LC as Secretary and ST as Treasurer. He explained that there were no candidates for these positions and as such would ask if there were any objections to their re-election. There was none so they were dually re-elected.

She also expressed that all s/o stop at the end of the season and start again at the beginning of next season.

LC spoke about registrations for next year. It was decided that registrations would take place over two weekends again and that dates would be advised. It was stated that on the day no registrations would be

accepted unless complete. LC advised managers of the most common problems

- 1- Using the same pictures as the previous season
- 2- Initials of player instead of signature

LC advised managers that the FA had ruled that Clubs who have more than one team in any age group can no longer be called Team A and Team B. There was a discussion and SS and ML put forward Team 1 and Team 2 this was discussed and by an unanimous vote it was carried.

LC asked managers to get the trophy winners names in as soon as possible. She also explained that ML team last year won a trophy and as the trophy was to be renewed this year the League had asked that for a minimum fee we could retain the existing trophy and the new one would be called the Hamsey Rangers Trophy. All thought this was an excellent idea.

NT asked if training could continue during the closed season at the club. MT explained that due to the work that would be happening this could not be accommodated. AB asked the committee to ask managers if they could be aware that HRFC were looking for new managers. These could be parents or players coming to the end of their playing career. NT asked about footballs for next season. A discussion ensued and it was concluded that the footballs from last season were not of good quality and could this be kept in mind when purchasing new ones. LC agreed to look into this.

SS thanked LC ST and MT for all their hard work during last season and everyone agreed.
